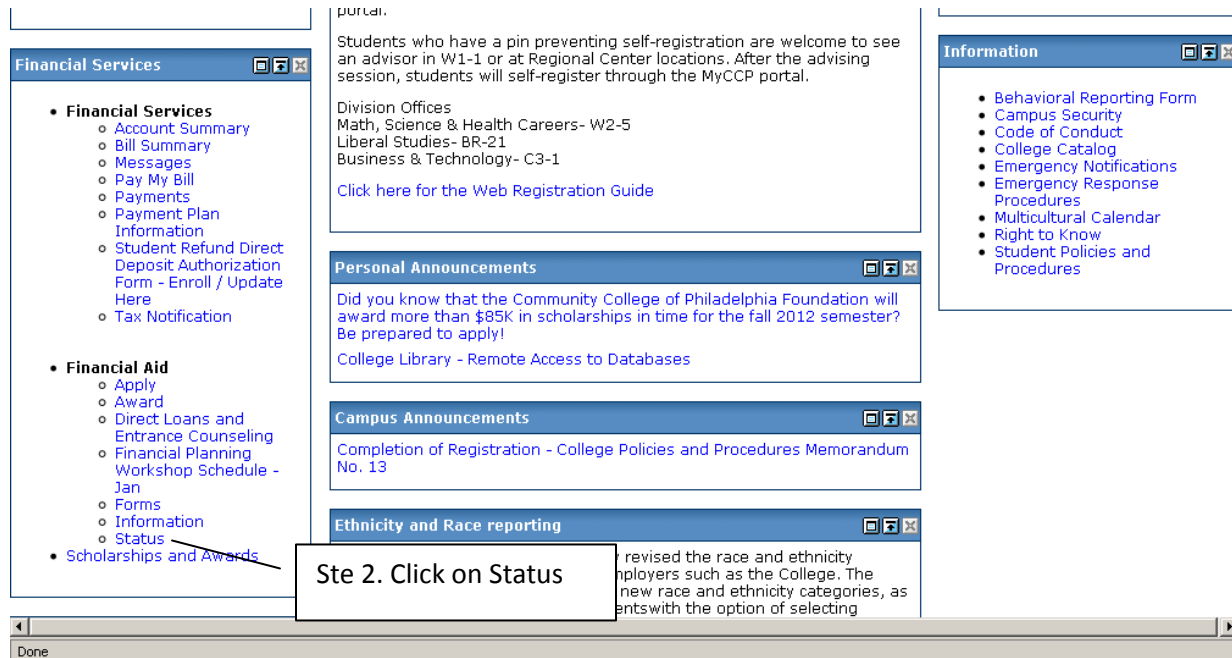
Steps:

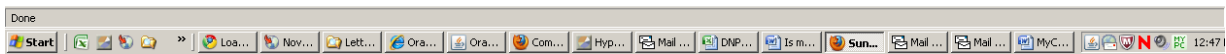

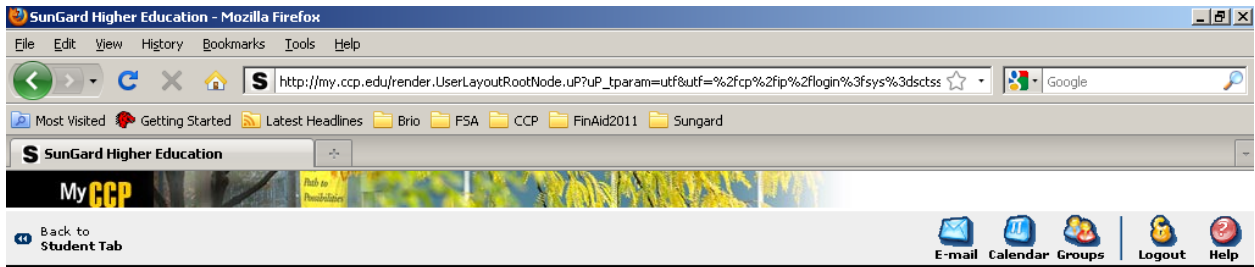

Get Ready for William D. Ford Federal Direct Student Loan (Direct Loan) Program!

Loans from banks (FFELP program) will no longer be available. Beginning July 1, 2010, the College is required by law to convert to the Direct Loan Program.

All students interested in taking out loans must complete an entrance counseling session and a new Master Promissory Note (MPN) at: www.studentloans.gov. Plan ahead and do these now!

(You must also complete a 2010-2011 FAFSA at www.fafsa.ed.gov, if you have not already done so).
