The Community College of Philadelphia will grant degrees and academic certificates only to students who have earned at least 30 credit hours in residence (at the Community College of Philadelphia) for a degree and 15 credit hours for an academic certificate. Students on active duty with the Armed Forces need to earn 15 credits in residency for a degree. Approved Prior Learning Assessment can be counted towards the residency requirement.
- ii. Eliminate the paragraph which begins with "Students who have earned..."
